1970 Population of North Dakota by Township and City

This report presents 1970 census population counts for the State of North Dakota by township and city. In the 1970 census, counts were not tabulated by township in North Dakota as in previous censuses. Prior to the 1970 census, the government of the State of North Dakota had worked with the Bureau of the Census to subdivide the State into larger geographic units called census county divisions (CCD's), and data from the census were published for these areas rather than for townships.

CCD's were frequently composed of groups of townships, although in some cases CCD boundaries bisected townships or included territory not organized for township government. CCD's had the advantage of greatly reducing the number of areas for which counts must be maintained, and of providing populations sufficiently large to permit the presentation of most sample statistics from the census. The CCD's are also designed to maintain continuity of census areas from census to census, which was not always possible with the townships because of frequent organization and disorganization actions.

With the inception of Federal general revenue sharing in the 1970's, however, there was need to determine the population of North Dakota townships for use in the formulas for allocation of Federal funds to areas below the county level. The Bureau of the Census has reconstructed the counts for townships from the records prepared by the 1970 census enumerators. The numbers are presented in the following table showing county subdivisions.¹ The table, which is modeled after table 10 appearing in each State report and in the "Number of Inhabitants" report from the 1970 census, shows 1970 and 1960 populations and percent change in population for all areas. The numbers are consistent with the CCD populations already published for North Dakota for 1970.² City totals are unchanged from the census report except for corrections in counts made after the 1970 census tabulations were completed.

All data are presented for areas as they existed on January 1, 1970. Footnotes to the table document boundary changes and township status changes which were reported since 1960. Although not reflected in the data shown in the table, numerous boundary changes and status changes occurring in the State after January 1, 1970 are noted in the appendix. These post-1970 changes have been utilized in population updates for Federal general revenue sharing purposes in the 1970's.

A map showing the townships and places in North Dakota as they existed on January 1, 1970 also is shown, together with a map index for locating counties on the map.

Population estimates for North Dakota counties are published annually in *Current Population Reports*, Series P-26. The latest report in that series, No. 75-34, presents estimates for July 1, 1974 and July 1, 1975. Population estimates for July 1, 1975 for cities and townships in the State will be published in Series P-25 in early 1977.

¹ Populations for 1970 published earlier in *Current Population Reports*, Series P-25, No. 579 were based on the 20-percent sample detail from the census. As such they may differ from the complete count presented here.
