Bone-Dry Law Modified.

physicians, hospitals and health authorities for permission to import whiskey and brandy into the state for the treatment of severe cases of Spanish influence and pneumonia, Attorney General William Langer has issued a ruling modifying the

The new ruling of the attorney general recognizes whiskey and brandy as medicines and permits their importation as such by registered pharmacists only, in the manner provided for the importation of alcohal

Attorney General Langer stated that this ruling is not to be construed as "taking off the lid" of the hone-dry statute and issued the fol-

lowing statement in explanation of

his action:

"Within the last few days many physicians and health authorities from various parts of the state have advised me that whiskey and brandy can be used advantageouly in treating severe cases of influenza and pneumonia and have asked permission to secure limited quantities of these liquors for such purposes.

"Upon the strength of such repre-

sentations on the part of these physicians and health authorities and in order that nothing may be left undone in the efforts to check the further ravages of these diseases, I have held that whiskey and brandy may be considered medicines and can be brought into the state for their treatment, in the manner prescribed by law during the period of the epidemic only. Under the law such liquors must be obtained thru registered pharmacists who are generally informed concerning the procedure
