

**OFFICIAL PROCEEDINGS OF THE**

**Board of County Commissioners.**

Sherbrooke, N. D., April 27th., 1896.

Board of County Commissioners met at 10 o'clock A. M. pursuant to adjournment. Present, Chairman Brown, and Commissioners: (W. H. Hagan, Cochrane, Rindy and King.

The minutes of the meeting of April 5th., 1896, were read and approved.

The time set for opening bids for lumber for bridges, for hauling lumber, and for building bridges, having now arrived, it was on motion ordered, that the time for opening said bids be postponed until 11:30 o'clock, A. M.

The bill of Baidler & Robinson Lumber Co., for extra planks for bridges built in 1894, \$17.93, was on motion allowed and ordered paid from the Bridge Fund.

The bill of Dr. J. L. Eranson, for medi- cal attendance on Christ Bentley, \$47.00 was upon motion disallowed.

The bids for bridges were now opened and examined. Action on same was deferred until afternoon.

On motion the Board adjourned until one o'clock P. M.

Board reconvened at one o'clock P. M. Present, all members.

Some time was spent in consultation with the assessors.

The consideration of the bridge propo- sals was resumed.

The bid of the Wisconsin Bridge and Iron Company, offering to build four iron combination bridges, as follows: Be- tween sections 17 and 20 Newburgh, between sections 19 and 18 Eager, be- tween sections 28 and 23, Eager, and between sections 14 and 15, Easton, and to build the other four bridges adverti- sed, according to plans and specifications on file, and offering to furnish all the material, and do all the work, except to haul the material from stations to bridge sites, for a total consideration of \$2316.09 was upon motion accepted and contract awarded.

On motion the bids of G. O. Norgaard, for hauling lumber for a bridge between sections 17 and 20, Newburgh, for 98c. per 1000 ft., and for hauling lumber for bridge between sections 31 and 32, New- burgh, for \$1.74 per 1000 ft., was accept- ed.

The bids of O. G. Major, for hauling the lumber for the Broadlawn, Edendale and Sherbrooke bridges, for \$1.50 per 1000 ft., was on motion accepted.

The bid of L. N. Bagbee, for hauling the lumber for the Easton bridge, for \$1.25 per 1000 ft., was upon motion ac- cepted.

An application was received from A. T. Drakeley, for a three years lease of east one-half of Block eight, in the Village of Sherbrooke, offering therefor the sum of \$8 00. On motion said ap- plication was granted.
