We believe 90 per cent. of the re-sidents of the county, feel that our county buildings are not folly ade-quate for the business of the county. quate for the business of the county, Everybody realizes the trouble and expense of going to Sherbrooke for county business, and it appears to us that our county has reached a place where they ought to have and can af-ford to have suitable accommodations, and buildings that they can be proud of. It is necessary before long to put some expense on the present buildings and it seems that this money should be put into permanent buildings. be put into permanent buildings. There is a danger under the present conditions that few, probably, serious-ly consider, and that is the danger of fire. In one of the Wisconsin counties if consider, and assessment of the interest in one of the Wisconsin counties their building burned destroying the records, and it cost the county more to get their records back into shape than a building would cost. An old frame building with no fire protection in the town, is a danger that cannot be overlooked, and several persons familiar with the county buildings have stated that they doubted whether the yaults would stand a fire in a strong wind.

strong wind. e objections have been raised to Some objections have neen raised ac-building a new building on the ground that the county is not yet in shape to do so. We cannot see where anything can be gained by waiting, as the can be gained by waiting, as the county is out of debt and as we understand it cannot establish a building fund in advance under the present law. Our county now has reached about \$400,000.00 of assessed valuation, so it would not be necessary to issue bonds as a tax of 10 mills would furnish a fund sufficient to build proper build-ings. An assessment of this size would mean \$8.00 or \$9.00 on a quarter section of land. Or it could be levied in say three years at about \$3.00 per

in say three years at about \$3.00 per year on a quarter section.

Under the present law we cannot vote on this again for ten years and during that time unless we move this fall'tiwill be necessary to spend considerable money in Sherbrooke in the way of repairs, and as stated it would seem that this money would practically be thrown away, as we do not think it would be possible to get the county to vote to put permanent buildcounty to vote to put permanent buildings off the railroad, so why take the chances of hanging this up for ten years. Don't do it. Study this ques-tion from all sides and see if you tion from all sides and see if you think it wise. Then look carefully into the claims and advantages offered by the different places, and vote to locate the county seat in the place that offers the best advantages.

LOCATION

Hope is as nearly centrally located as any railroad town in the county.

POPULATION

INCORPORATION

Hope is the only City in the county, being incorporated as a city, divided into three wards and governed by a mayor and a board of aldermen.

ACCOMMODATIONS
Hope has greater hotel accommodations than all other towns in the county combined. It has three hotels alone with 85 sleeping rooms, also numerous restaurants and eating houses and private boarding houses and sleeping appartments.

IMPROVEMENTS

Hope has a dozen streets graded— those entering the business section be-ing paved with gravel and here mud is an unknown quantity. Four miles of cement walks have been constructed along these streets at a cost of \$15,000 and a crew of men are extending these walks further out daily.

FIRE DEPARTMENT
Hope has far the best equipped fire department in the county. The apparatus supported here has cost the city more than \$5,000, The equipment consists of a 24 horse power Waterous Gas Engine, one Hand Chemical Engine, Hook and Ladder Trucks, fully equipped, two hose carts with more than two thousand feet of 2½ in. hose, with which forty-four blocks can be reached without moving the engine. Seven cisterns are located in different portions of the city for use of the deportions of the city for use of the deportions of the city for use of the de-partment with a capacity of one hun-dred thousand gallons of water. Three fire companies are maintained with complete organization having fifty four members.

SCHOOLS

The city of Hope has the only first class State High School in the county, the handsome brick building costing \$20,000. The schools are in charge of a city superintendent and a faculty of nine instructors. The High School course covers four years work, all fin-al examinations being state examina-tions, and graduates enter the State University or Normal schools without further examinations. One year being sufficient to complete the Normal School course. The school building is equipped with steam heat, electric lights, water works, chemical, physical and botanical laboratory, and Gymnasium.

ELECTRIC LIGHT PLANT
Hope has the only electric lighting
plant in the county, the total cost of
installation being \$30,000. All the business houses, public buildings and residences are electric lighted and the streets are lighted with thirty five are lights in operation all night
