The board of county commissioners reconvened at 9 o'clock a m pursuant to adjournment. All members present.

On motion K. S. Sulland and H. N. Horner were appointed as a committee to go at once and inspect bridge on line between sections 9 and 16, Newburgh twp., said bridge having been reported in bad condition. Minutes of the meetings of July 5th, 1904, read and approved.

On motion Chairman appointed Elliott, Gray and himself as committee to check up Register of Deeds' books and records.

On motion the board adjourned until 1:30 p.m same day.

AFTERNOON SESSION

The board of county commissioners reconvened at 1:30 p.m. Present G. O. Johnson, W. E. Elliott and Frank Gray.

The committee having completed checking up Register of Deeds' books and records reported that they found the records and accounts satisfactory. Same committee checked up Clerk of Court's records which they found O. K.

The following county warrant having remained on hand uncalled for for more than 6 years was ordered cancelled and destroyed: No. 1467 to W. C. Gleason, witness fees, issued Jan. 12, 1897. \$2 00

On motion the County Auditor and Treasurer were authorized to prepare and have published in the Finley Beason, a financial statement of the County for the year ending June 30th 1904.

On motion the Treasurer and Auditor were authorized to transfer \$2 00 from the interest and penalty fund to the bridge and road fund.

The auditor was on motion instructed to advertise for bids to furnish the County with 20 tons hard nut coal delivered in cellar of County building not later than November 1st 1904. Bids to be opened at 2 o'clock P.M. October 3rd, 1904.
