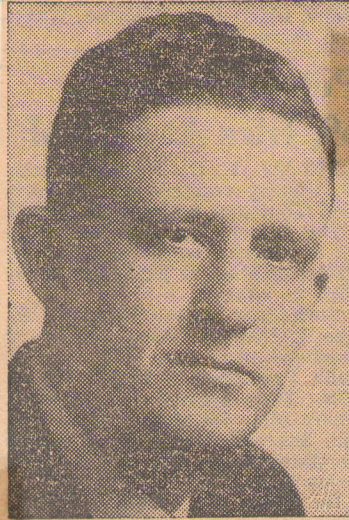
G. E. Miner Dies at 53

Glen E. Miner, 1924, president and general manager of Lystad and Redick, Inc., died unexpectedly January 7 in a Grand Forks hospital. He was 53 years old.

Mr. Miner was born at Spencer, Ia., April 22, 1901. He received his early education at Kenmare, N. D., and entered the University of North Dakota in 1920, attending four years, and receiving a bachelor's degree in commerce.

He married the former Marcia Cussons of Cooperstown, at Breckenridge, Minn., June 5, 1924. She survives, with a son, Richard, also in the employ of Lystad and Redick; a brother, Melvin C. Miner, Seattle, and two sisters, Adah Miner, Seattle, and Mrs. J. W. Stannard, Williston, and his mother, Mrs. Myrtle Miner, also of Seattle. Another son, Robert, was killed in World War II.

Mr. Miner was employed by Northwestern Bell Telephone Co in Fargo after graduation from the University. He later was transferred to Sheridan, Wyo., with the Mountain States Telephone and Telegraph Co. He returned to Fargo in 1926 and later the same year went to work at Mandan. Later, he was transferred to Harvey, and remained with Northwestern Bell until 1930, when he moved to Langdon with Central West Public Service Co. He was employed in Devils Lake from 1930 to 1932.

Sandra Hammond, Fargo, was flower girl. She wore pink organza and carried a white basket with white flowers.

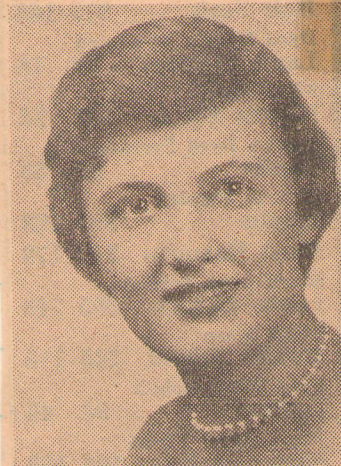
The mother of the bride wore a navy blue dress and the mother of the bridegroom wore green. Their corsages were of pink roses and carnations.

Breeding beef—Carol Hoffmeyer, Cooperstown, grand champion; Donald Briss, Binford, reserve champion.

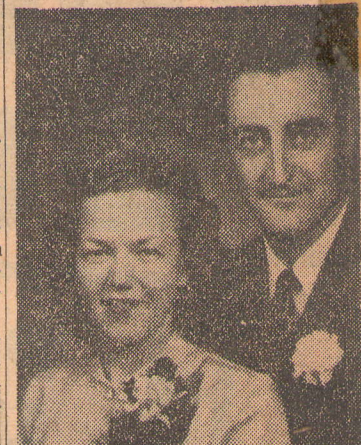

H. J. Michaelis Dies At 79

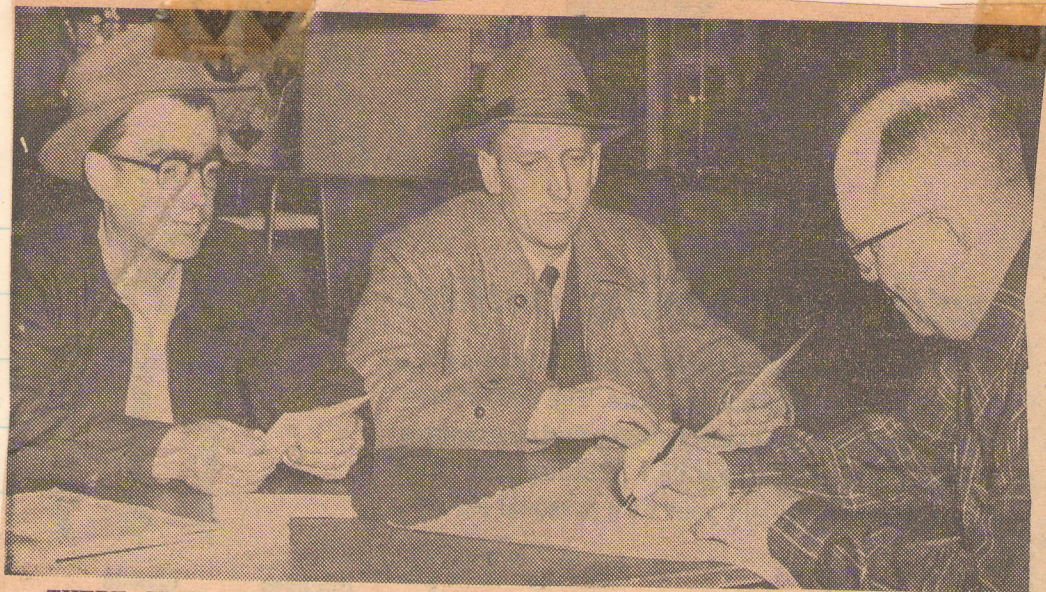
COOPERSTOWN, N. D. — Herman J. Michaelis, 79, a resident of this community since 1881, died at his home here Tuesday.

Uncover Seed Wheat Scheme In Griggs Area

A scheme to sell seed wheat at \$750 a bushel has been uncovered in Griggs County.

Irvin D. Morrison, Griggs County extension agent, said that rural mailbox holders were offered seed of a Poulard type wheat at \$5 per packet of 300 seeds.

To make farmer think that this was a rare variety, the offer limited one person to six packets, he said. At this rate, the wheat would sell for about \$750 a bushel.

Poulard wheat is an European type grown in the Mediterranean area, according to NDAC cropsmen. It may have either winter or spring wheat characteristics, and it is most easily recognized by its large branching head as compared to the single head of our common wheat.

R. B. Widdifield, NDAC extension agronomist, said that the North Dakota Experiment Station has tested Poulard wheat in the past, and it has found the wheat inferior to recommended varieties both in yield and in milling and baking quality.

Henry O. Putnam, secretary of the Northwest Crop Improvement Association, said Poulard is classified only as a feed grain and is useless in this country.

Alaska is the principal variety of this type of wheat, although it goes under other names such as Miracle, Egyptian, King Tut, Seven-headed Wonder and Mortgage-lifter, he added. The yield is low, and it cannot compete with other standard field grains for feed production, Putnam says.

As to resistance to race 15B stem rust, Widdifield believes that Poulard wheat is no better than other wheat varieties of this area.

Bismarck 72 Years Ago Became Capital Of Dakota Territory By Fast Maneuvering

BISMARCK, N. D. (P)—Seventy-two years ago Thursday a legislative commission in effect took a capital off wheels and settled it here.

Actually, the operation involved the plucking of the capital of the Dakota Territory from Yankton, on the Missouri River at the Ne-

braska line and establishing it in Bismarck, in the approximate center of what six years later became North Dakota. The operation, by the way, required a bit of doing.

Such doing, historians say, was strictly up the alley of Alexander McKenzie, a genius at politicking who had landed hereabouts in 1867

in search of, as one historical writer put it, "whatever rewards might fall to the lot of a young man of brains and enterprise."

Whether McKenzie's getting the capital shifted from Yankton to Bismarck was divinely inspired or a diabolic outrage depended on where you lived.

The folks at Yankton snorted and started legal proceedings in a futile effort to put a stop to the move. The northern half of the Dakota Territory rejoiced, and The Bismarck Tribune of that day attributed the development to the Almighty's interest in the situation, with McKenzie as an instrument in bringing it to pass.

Six years later the territory was divided into two states and the matter of where the territorial capital was didn't cut any more ice.

The version usually heard about the territorial capital transfer is that McKenzie went to Yankton for the 1883 session of the territorial Legislature with one purpose—to fetch the capital to his adopted home town of Bismarck as an assignment of James J. Hill and his Northern Pacific Railroad.

One man, however, who served on the commission of nine later named by legislative action to pick a new capital site recounted in his memoirs that removal of the capital from Yankton was sprung unexpectedly on the legislators and that none of the lawmakers had any idea that the possibility was imminent.

With more than 70 years in which to hindsight the situation, how-

ever, one gets the impression that Alex McKenzie didn't make the 500-mile trip from Bismarck to Yankton just for the ride on the steam cars.

He had a way with people—although the only public office he ever held or sought was sheriff of Burleigh County here—and he got on fine with Gov. Nehemiah G. Ordway and apparently virtually everybody else with whom he came in contact in the legislative halls.

He was not a member of the territorial Legislature. He took in the '83 session, according to the historians, as an observer. Lobbyist registration was not required in the '80s, when legislators were grinding out laws which included one declaring a public nuisance "any room, cellar or other place" used for the smoking of opium.

Just what definite arrangements McKenzie made are not chronicled, but shortly before the '83 session ended at Yankton, a bill to transfer the capital from Yankton to Huron was offered.

One historian says the purpose of this bill, which came to naught, was to divert attention from preparation of another bill, inspired by McKenzie and introduced a little later, to move the capital from Yankton.

The second bill passed the Council—the equivalent of the Senate—by a vote of 7 to 5, and made the grade in the House 15 to 7.

It was quite a bill. It said nothing about moving the capital to Bismarck. It did, however, authorize its removal from Yankton, and it authorized a 9-man commission to pick a new location elsewhere in the territory. What is more, it designated the nine men—including McKenzie, who ultimately became the commission's chairman.

One version is that "an army of deputy sheriffs" stood on the platform as the train steamed past the depot. Another is that the sheriff waited on the platform but simply couldn't get opportunity to get aboard the train until the commission had organized.

Anyhow, the court order that was to have prevented organization of the commission wasn't served, the commission did organize, and then went on a sort of triumphal tour of all the territory towns that had bid for the capital.

At most places the commissioners were served sumptuous dinners. But at one place the women who served the meal balked at permitting liquor and cigars at the table. At other places the hosts were not as squeamish; champagne corks popped merrily and you could have cut the cigar smoke with an axe. Bismarck was the last town visited, and here the good people piled a banquet table with a gar-

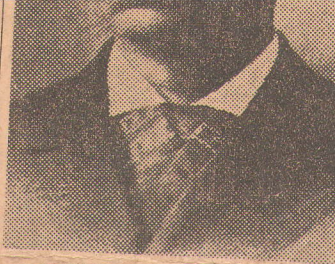

"Late Alexander McKenzie of North Dakota—the great politician. The only photo of him known to be in existence. He instructed me not to sell, or let any person have one of these photos." The picture is not dated.

Actually, in the last years of his life, other photographs of Mr. McKenzie did become available. His friends figured, after they learned of his Yonkers family, that he avoided use of his pictures in newspapers because of the thought that through such publication the story of his second marriage might become known.

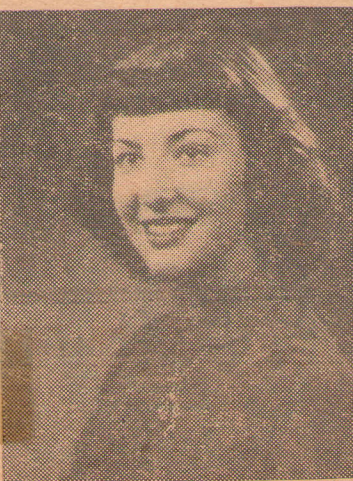

The minority commissioners had contended that the man nominally the labor representative on the board—George Seiler—did not have the backing of labor.

Carl Peterson, counsel for the Fargo Urban Renewal Agency, who said he was appearing as a citizen, urged the appointment of Alan Foss, also an attorney and one of six whom Lashkowitz had recommended.

Peterson said Foss is a friend and the Commission "couldn't possibly find a man more qualified to serve the city and its employees."

Markey moved that Foss be appointed and when there was no second Lashkowitz relinquished the chair to support the motion. It lost 3 to 2.

Markey said that to appoint McWethy to the post as a representative of business and management would give three such representatives on the three-man Civil Service board, contending that George Seiler, who is a printing shop foreman, and Nels M. Roswick, a truck terminal manager, both represent management. Roswick was appointed to represent the public-at-large.

Appointing Foss, Markey argued, "would be one way to get away from this stalemate."

McCannel declared that the Civil Service Commission "has operated successfully for many years. McWethy's name has been proposed for weeks, but has never been allowed to come to a vote. I wonder why."

Lashkowitz said the question had been broached as to whether McWethy has been a member of a political party committee in the past year, which would disqualify him under the city ordinance.

When other commissioners said they did not know, Lashkowitz called McWethy by phone and told the Commission that McWethy said he has not served on a political party committee.

Lashkowitz said he had no objection to McWethy personally "but I object to an attempt by a group to apply pressure."

I stayed with her until two o'clock but she slept and got warmer and I thought she was over it so went back to the hotel. Two hours later they called me and said she had gone out very quickly while asleep.

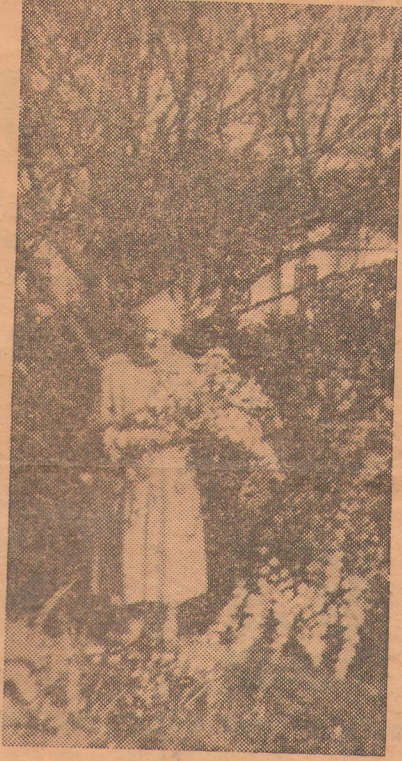

Down The Trail With Our Pioneers

Mrs. Julia Cooper Merriell was born at Red Wing, Minn. September 20th, 1860, and in 1862, her father, T. J. Cooper brought his family to Colorado. He was in the business of outfitting the covered wagons and supplying the settlers with what they needed for the gold rush days in Colorado. The family moved back to Chicago where, Julia grew to womanhood and in 1884 she married W. A. Merriell. They returned to Central City, and from there to Oak Park where her only child, Frank C. Merriell was born. In 1885 Mrs. Merriell went to Denver to find an altitude better suited to her and her husband, who had been "looking over" western Colorado where they could "settle and help in building up a new community" decided that Fruita was the ideal location. He purchased property and brought his small family to their new home. He had the first lumber business and in a short time was interested in all phases of the development of the lower valley. In 1902 Mr. Merriell organized the First Bank of Fruita, and was prominent in business as well as religious and civic activities, and they were both members of the Congregational Church, which was the center of their social life. Mr. Merriell passed away in 1937, and the Fruita Congregational Church was perhaps the last service held there. The church was sold, leaving only memories of the fine type of people the Merriells had enjoyed in their life in Fruita. They were proud of their wonderful friends, and she remembers particularly such families as the John Carnahans, J. L. Warrens, William Warrens and Sadie Warren. She also made a special mention of Benton Canon who was here when they came and helped them. He made the second trip across the plains with them in 1864, and so had known the family.

Mrs. Merriell's son was overseas in 1917-19. Captain Merriell won his commission in the second officer's training camp in Fort Sheridan, near Chicago, in 1917 and served as an instructor in the engineers' service, with quarters at one of the famous mili-

tary schools of France. He is now engineer for the Colorado River Water Conservation District. She has resided with her son in Grand Junction since the death of her husband, and her philosophy of "living each day" and her devout interest in her church has kept her young at 91. She still does much of her housework, maintains a wide correspondence with her friends, and keeps in touch with the world and lives among her treasures of former years.

Reading is her hobby, as it is her son's also. His are the more technical books while she enjoys VanDyke, the favorite, which is always close at hand and gives her comfort and inspiration in his "Out-of-Doors in the Holy Land." Among her treasures is a painting of her grandmother Caroline Baker Cooper of Vermont. Her father had the painting made from an old daguerreotype, and it has a gorgeous antique frame. She also has a quaint enchanting hand-painted plate which her father brought her from New York when she

was a girl, and two huge vases which a close friend brought from the Orient. They are unique in shape and design and she believes they are Korean in origin.

Her first trip across the plains was made when she was two years old, they came from St. Joseph, Mo. to Denver in a covered wagon. Two years later they crossed again to Helena, Montana. This second trip she remembers slightly, particularly the return trip down the Missouri River by boat and the day when their progress was held up by a tremendous herd of Buffalo which was crossing ahead of them. The worry of the Indians this trip, was lightened by the fact that her father met an Indian Chief who had attended a church school in Red Wing, and who promised that he would warn the Indians along the route that this particular train was not to be disturbed.

Mrs. Merriell has voiced one regret in her life, and that was, she has never been able to attend any of the summer performances at Central City now held in the old Theatre, to perpetuate the memory of the picturesque old days her family knew so well. Her husband and her father knew the Tellers and the Tabors and other members of the group which made Central City outstanding in the early days.

She was one of the early presidents of the Progressive Woman's Club of Fruita, and she was also an early Worthy Matron of the Eastern Star Chapter of Fruita, known now as Carnation Chapter; a name, which was submitted by her and later chosen as the Chapter's permanent name.

This picture of Mrs. Merriell was taken in San Diego, Calif. in the spring of 1948, when she made the trip by plane. Thus she traveled Westward both by covered wagon and by plane.

Mrs. Merriell does not live in the past, her alert mind and energetic personality might easily be cherished by women much younger. She keeps young in her thinking and reads many books on many subjects. She lives each day as it comes and her life has been full and interesting.

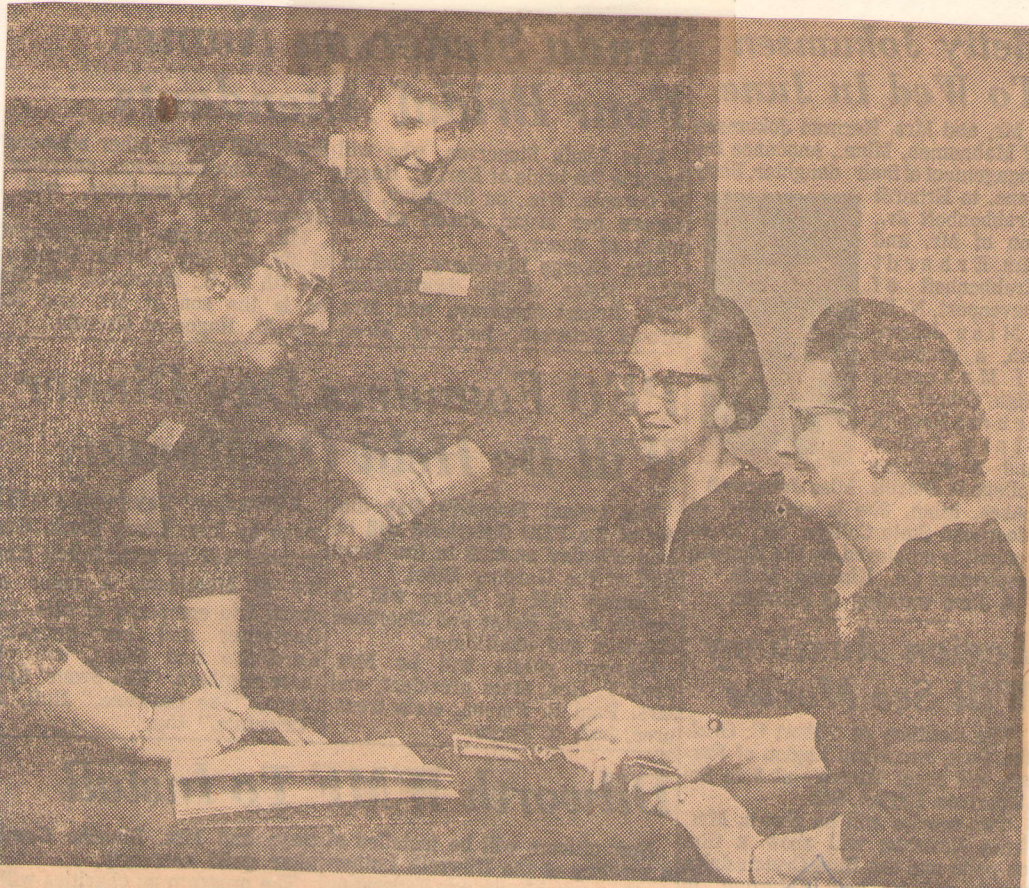
