### Came to Griggs In 1889; Dies While on Visit To Sister in Wahpeton

Funeral services were held for David Sansburn, pioneer Griggs farmer, who passed away Saturday in a Breckenridge, Minn., hospital. Rites were conducted by Rev. C. C. Converse in the Presbyterian church of this city.

Sansburn, well known to Griggs residents, came to this territory in 1889 and until six years ago had been actively engaged in farming. He was 76.

Born at St. Mary's, Ont., March 25, 1863, he grew to manhood there and came to North Dakota in April, 1899. He settled on a farm six miles north of Cooperstown and made his home there until 1933 when he moved into the city.

He was married to Miss Josephine Carlson in August, 1902, and to this union five children were born: Clarence, Charles, Mrs. Theo. Monson, all of Cooperstown, Mrs. Georgie Olson of Egeland, N. Dak., and Margaret of Wahpeton. His wife died in February, 1917.

In April, 1919, he was married to Mrs. Belle Monson.

Surviving are his wife, his five children and three step-children, Mrs. Lawrence Pederson, Lawrence Monson and Mrs. Gilmar Christopherson. Four brothers and two sisters also survive: Samuel of Grand Coulee, Wash.; John of Windsor, Ont.; William of Cooperstown; James of Ravensdale, Wash.; Mrs. Nellie Jones of Wahpeton and Mrs. J. H. Langford of Cooperstown.

Sansburn was a member of the local chapter of the Knights of Pythias, members of which acted as pall bearers.

### Once Served Here As County Superintendent of Griggs Schools

Andrew Sinclair, 74, former resident of this city and one-time superintendent of schools of Griggs county, died at his home in Absarokee, Mont., Sunday. Death was due to a heart attack.

Funeral services were scheduled today in Absarokee, with burial at Columbus, Mont.

Sinclair was born in St. Mary's, Ontario, March 7, 1866, and came to this territory in 1884. He taught school in Griggs county for several years, was elected superintendent of schools and served in that capacity for six years. He also spent several years in the banking business.

In 1895 he was married to Florence Haskell of Cooperstown. One daughter, Florence, was born to the union, at which time Mrs. Sinclair passed away.

Later he was married to Bertha Zimmerman, also of Cooperstown, and to this union three children were born. In 1913 the family moved to California, resided there five years and removed to Washington.

In 1923 the family returned to this community and Mr. Sinclair took up farming south of this city. A short time later, however, they returned to Washington and since that time have resided also in Michigan and Montana.

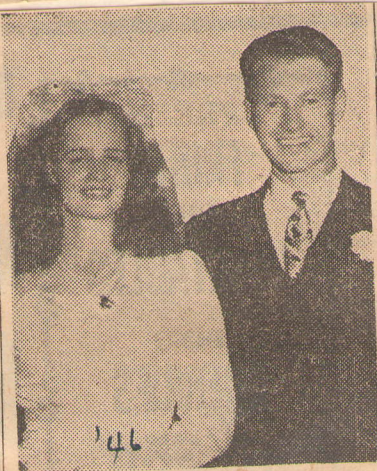

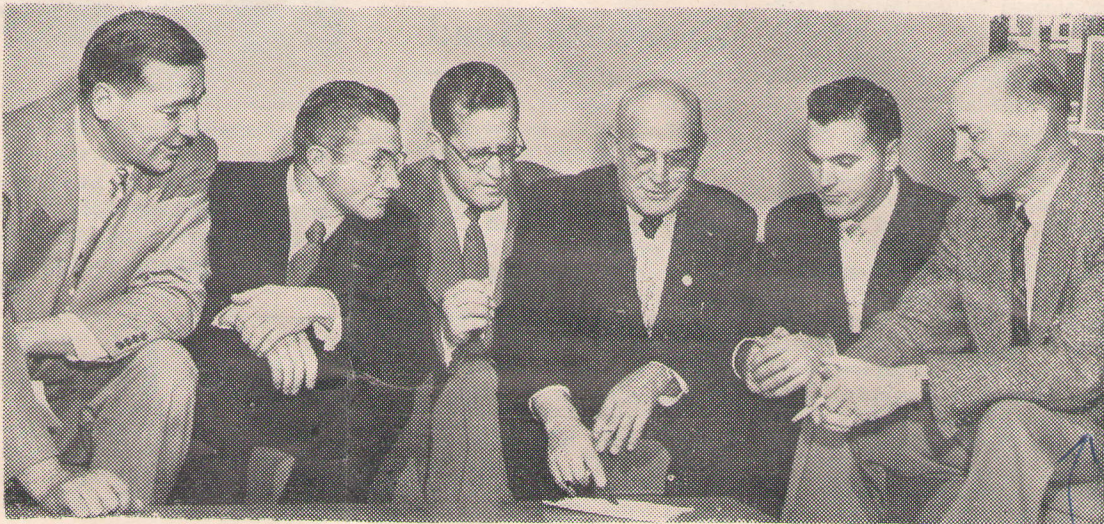
