

OFFICIAL PROCEEDINGS of the Board of County Commissioners.

Sherbrooke, N. D., July 20th., 1895.

Board of County Commissioners met at 10 o'clock a. m., pursuant to adjournment. Present, Chairman Brown and Commissioners Williams, Cochrane, Rindy and King.

The minutes of the meeting of the Board of Equalization, of July 8th. and 9th., 1895, were read and on motion the same were approved.

The minutes of the meeting of the Board of County Commissioners of July 9th., 1895, were read and approved.

The committees appointed at the last meeting of the Board, to inspect bridges, filed their reports which were read and on motion accepted, and committees discharged.

On motion the Board adjourned until 1:30 o'clock p. m.

Board reconvened at 1:30 o'clock p. m. Present, all members.

On motion the bill of the Wisconsin Bridge and Iron Co., for balance due for building bridges, as per contract, \$1316.00, was allowed and ordered paid from the Bridge Fund, at \$1721.00, amount to be paid in two warrants, one for \$1200.00 and one for \$491.00.

On motion the bill of J E Dyrland, for hauling planks for Enger bridge and for extra trip to Portland and Hatton, \$9.98, was allowed and ordered paid from the Bridge Fund.

On motion the bill of L. N. Bugbee, for hauling irons from Portland to the Easton bridge, \$4.00, was allowed and ordered paid at \$3.00, from the Bridge Fund.

An application was received from Wamberg & Jacobson, for the purchase of S. 76ft of lot 21, block 24, Hope, offering to pay therefor the sum of \$3.50. On motion said application was granted and a quit-claim deed ordered issued.

The County Treasurer's accounts and vouchers having been examined and found correct were on motion accepted and approved.

On motion Commissioners Brown and King were appointed a committee to meet with the Board of County Commissioners of Griggs County, when bids are to be opened for the construction of the bridge near south-west corner of section 31, Riverside Township, and said committee is hereby empowered to act on behalf of Steele County, in considering said bids.
