The weather up to the middle of June was most discouraging in some respects. More than half the time it was cold, rainy and dismal. The only relieving feature is, that wheat made good progress, and that other things were only set back and destroyed. June recreations were at a discount and the lakes were decidedly unattractive to anybody but fishermen, who were oblivious to anything but their "strings."

Every week brings another chapter of disastrous incidents from cyclones and tornadoes. Several lives were lost last week in Missouri, Iowa and Wisconsin and a good deal of property destroyed, which, with greater fatalities heretofore reported, rake up a sad record thus early in the season. It is hoped that the worst is over, but nobody, not even the scientists dare say what a day may bring forth in the way of elemental de-

Referring to the recent seizure by the

government at New York of 75 packages scented Caper teas, and the stoppage by the New York board of health of a sale of 3,000 pkgs Pingsuey teas, 1,000 pkgs of which belonged to a Boston firm and the remainder to an English syndicate, the Boston Commercial Bulletin says "that the United States has been the dumping ground of all the poor, refuse and adulterated teas from China and Japan," because the English law prohibits the importation of such stuff into Great Britian. What is still more remarkable is the statement that an Engish syndicate imports most of this trash into the United States. It is purchased in the primary markets at small cost, and wholesaled in New York and elsewhere at 12 to 20c per lb. These poor teas are put on the market through the auction rooms and gift tea stores. The result is the consumption of a great deal of cheap and poor teas to the exclusion of good teas. It is now very difficult to get pure teas. From the Forthcoming Autibiography.

I never possessed the power "to speak in public on the stage." This was my first and last attempt, either in that house or in the assembly of 1830 when I was again a member.

THE NEWS IN BRIEF

GOSSIP FROM WASHINGTON. A reporter asked adjutant Gen. Drum if any further steps were contemplated toward court-martialing Maj. Nickerson. "First catch your fish," was the reply. It is said that Mrs. Nickerson, who is at the Arlington hotel, will apply to the war department for a portion of her husband's pay. Secretary Lincoln said that no such application has been made and that he had received no information on the subject. A prominent officer of the department said that it would be difficult to give her any of the salary without giving the remainder to Maj. Nickerson. It is reported that Maj. Nickerson is in the city, but no information of his whereabouts has been received at the war

Considerable comment is being indulged in about the departments on the information that certain lists of questions have leaked out of the hands of the civil service commission. If the questions are to be given out beforehand to favorites, those who anticipate going into the competitive examination want to know whom the favorites are against whom they must compete. The government printing office has just completed the questions for the classified customs service, and the job has been delivered under seal. In the case where the questions have leaked out new ones must be prepared.

The Chinese legation, which has occupied the handsome residence of ex-Governor Shepherd, on Farragut square, for several years, is about to remove to an humbler home on H street. Shepherd's \$100,000 residence was rendered disagreeable by the fact that his creditors were trying to get their hands on it. The presence of a for-eign legation prevented an actual ejectment, but the legation wearied of acting as a buffer between two claimants.

The president had another consultation with Secretary Folger recently, upon the subject of the proposed condition of internal revenue districts. It is understood that for all the states, except Indiana and New Jersey, plans of reorganization have already been agreed upon.

The findings of the Wasson court martial have been received by the judge advocate general. The result has not been made known, but it is thought that his sentence is at least dismissal, otherwise the department commander would have acted upon it.

Ex-Detective Wood has written Secretary Folger, stating that the secretary is in dan ger from the ex-convict, Mason. Mason denies ever having threatened anybody.

Senator Sabin arrived in Washington last Friday night from New York. He will remain some days.

RAILROAD RUMBLINGS.

According to the Bismarck Tribune, the Milwaukee & St. Paul and Northwestern roads have secured all the land they want for terminal and other facilities in that town. The amount purchased is something over 2,000 acres. An Appalling Panic. A terrible calamity, involving the death of 178 children; occurred in Sunderland, county of Durham, Saturday. From details received it appears that an entertainment was given at Victoria hall by a conjurer, attended almost altogether by childrer, several thousand being in attendance. The accident occurred at the close of the performance. The body of the hall had been entirely cleared of occupants, when some 1,290 of the little ones came rushing down stairs from the gallery. At the top of the first flight of stairs was a door which opened only twenty inches, and thus but one child was permitted to pass through at a time. At this point, while the mass of children were pushing forward, one of them fell and was unable to rise, owing to then fell and was unable to rise, owing to the others crowding. No effort could stop the mad fury of the frightened children. They came on pell mell, though strangely without much shouting, and soon 173 children were knocked down and suffocated to death by others trampling upon them. The death by others trampling upon them. The greater number of bodies, which were badly mangled from trampling. laid seven or eight deep. Many victims and others who were not killed had their clothing torn from their bodies, and this together with the bleeding bodies of the unfortunates, shows the terrible nature of the struggle. The ages of the 173 children ranged from four to fourteen years. The excitement in town, when the news spread, was terrific. Great crowds rushed to the scene until 20,000 persons surrounded the hall. SOUTHERN DAKOTA.

The Body Formally Organizes and Adheres to the Main Purposes of Division and Statehood.

A Constitutional Convention Called to Meet on the 4th of September.

DIVISION AND STATEHOOD.

HURON, Dak., Special Telegram, June 19.—
The convention was called to order at 12 o'clock, the large delegation quite filling the Wigssm, which was duly decorated for the occasion with flags, and over the rostrum with a picture of George Washington and the words State of Dakots and Fear God and Take Your Own Part. Rev. Wilmot Whitfield called the convention to order. Two bands of music occupied the platform. The call was read at length and the chairman nominated for temporary chairman Hon. B. L. Caulfield of Deadwood, who thanked the convention for the honor conferred, and congratulated the people of Southern Dakota upon the demonstration of of Southern Dakota upon the demonstration of patriotism and the expression of love of independence and self-government in this convenion.

The people of this government, he said, had the right of self government and an enabling act was an innovation which need not be regretted. The sisterhood of States had never yet refused to admit to their number any State or community with the requisite number of population, characteristic and wealth of self government. We have assembled here to say te congress that we, the people of Dakota, have the right to Statehood and to right of the Admission As A STATE. OUR ADMISSION AS A STATE.

At his request Rev. Dr. Hoyt invoked the divine blessing. Phillip H. Lawrence of Kingsbury and W. B. McChesney of Brown county were elected temporary secretaries.

Judge Moody moved the appointment of a committee on credentials, made up of one from each county where there are no contested delegations. A resolution was adopted giving the committee power to consider the rights of the unorganized counties to a larger representation than the one provided for in the call A committee of seven on permanent organization was appointed as follows: C. H. Winsor, Judge Edmunds, W. L. Hamilton, E. S. Johnson, Gen. Pease, John Cain and E. S. Vorhees. A committee on rules and order, consisting of M. M. Grigaby, Judge Campbell, E. R. Rogers, J. C. Boyle and A. B. Melville, was then ap-

J. C. Boyle and A. B. Meiville, was then appointed. A recess was taken till 3 o'clock.

AFTERNOON SESSION.

When the convent on was called to order after recess the committee on credentials was not ready to report, and more than half an hour was filled with music by the band and short speeches by Judge Brookings and Judge Campbell, the latter of whom said that—

The occasion was one which required no sneeches, represented, as Dakota was, by the representative men of the country south of the forty-sixth parallel, of men from all wakes of life, demanding two things with surprising unanmity—the division of the Territory and Statehood. Let our action be calm and wise, so it shall not be said that we are not worthy to govern ourselves.

He thought that the enemies of the object of the convention were speedily becoming less, but opposition would undoubtedly be encountered and designing persons who would propose admission without division. He arged that decision be insisted upon as a cardinal principle in the fight.

A. L. Hamilton of Lawrence spoke in the

same strain, pointing out elequently that Southern Dakota had the population, the intelligence and the country to support such an independent government. Speaking for the Black Hills, he said that the 25,000 or 30,000 people in that country were standing shoulder to shoulder for division, and admission as soon thereafter as possible. The speaker spoke at some length with much warmth, and stirred the audience to shouts of applause and much enthusiasm.

EVERTHING SEBENE

EVERYTHING SEBENE HURON, Special Telegram, June 20.-The action which was clearly foreshadowed in the dispatches of yesterday, was had at the session of the convention for division and statehood held to-day. Aside from such natural rivalry as was necessitated by the choice of a place for the holding of the constitutional convention, and that entirely good natured, the deliberstions of the convention were singularly harmo-nious, and the line of policy foreshadowed on the day preceding the opening of the convention rigidly adhered to. There has been no ripple of disagreement, and in all the debate scarcely a reference to the capital removal matter, none whatever to political preference and little if any to the claims or rights of either the Territorial gov-ernment or the portion of the Territary north of the forty-sixth parallel in the convention No difference of opinion ever was developed on the question of the power of the convention to do just what it has done, and what it proposed to do through the aid of the constitutional convention which has been called. The convention was above the average in quality, aud, taken as a whole, superior in appearance and legislative ability to the most of the State legislatures. The foreign element was but sparsely represented, and the delegates were largely lawyers, business men, newspaper editors and farmers, with a liberal sprinkling of clergymen. The utmost enthusiasm prevails over the result, and confidence in the success of the project. A large number of the delegates leave for home to-

THE ADDRESS TO THE PEOPLE. The committee on address to the people sub-

The committee on address to the people submitted the following, which was adopted:

To the People of Dakota: When the sentiment becomes unanimous in the minds of 250,000 patriotic, liberty-loving, God-fearing people that there are certain rights to which they are envilled, but of which they are deprived, common fairness and common decency demand that respectful attention and consideration should be given to their claim for the exercise of those rights and privileges. For the purpose of emphasizing and torunally promulgating the claims which the clidens of the southern portion of Dakota make in the matter of statehood and in its rights and privileges, a convention of 350 delegates chosen from her several counties met at Huron, June 19, 1883, there being a full representation from every organized county but three and from a number of counties not yet organized. These representative men chosen by the several counties upon the definite issue of taking steps for securing statehood for that portion of the Territory designated, in convention assembled, they, as the duly selected representatives of 250,000 people, unsurpassed for intelligence and patrictism, most solemnly and with one voice declared it to the unalterable and absolute demand of that people, that they be vouchasfed the exercise of those rights promised them as citizens of these United States whenever they should number 60,000 souls, guaranteed to them by solemn treaty at the time the region, a portion of which they occupy, became a part of the domain of the United States; asserted for such as they, by the fundamental law of fourteen commonwealths and guaranteed to them by every precedent that can possibly be considered as bearing upon the issue.

and in due deference to the sisterhood, of which Southern Dakota desires to become a part, that the said convention should state some of the grounds upon which her claim is based, not only that those who might oppose it may have knowledge of their error, but that the people themselves may even more fully comprehend and realize what are their rights in the premises, and what is the necessity for their prompt, unswerving and persistent assertion of these claims and the enforcement thereof by all and overy means which individual or organized effort can devise or execute. And it is for the purpose of supplying this information that the commission has directed the preparation of this address. In the first place, let it be understood and known of all men that not a single feature of anything that is contemplated is any departure from dua and ordinary process, as recognized by the higher law of the land, by the repeated interpretations thereof by the most eminent judicial authority, and by the practices and customs which have prevailed from the earliest periods of our federal history. The entire movement which the southern half of Dakota is making to-day in attempting to secure statehood is pure and simple patriotism. The people of the southern portion of Dakota ask at the hands of the congress of the United States the division of the territory upon the forty-sixth parallel and the admission of that half into the Union, and they ask it as an unquestionable right. They ask division because the domain thus allotted to them even then would be larger than thirty other states in the Union, and it boundaries would be sufficient to contain the whole of the six New England states, or half of the four Middle states, and with resources capable of maintaining a population of 3,000,000, and to-day contains more than

They ask it because the interests, commercial and otherwise, of the different sections of the new Northwest extend in an east and west direction, and that, therefore, there is nothing to join the interests of Southern Dakota with those of the section from which she wants to be dissolved. They ask it because the characteristics of the two people are as different as could well be imagined; that of Southern Dakota being a people of homeholders and steady going citizens, comparatively content with the days of small things and themselves directly interested in the conduct of public affairs, while the affairs in Northern Dakota are more directly in the hands of large capitalists and extensive operators and speculators who are able to dictate the policy of the region by their influence upon the large bodies of farming people in their employ or under their control. No commonwealth could be satisfactorily managed wherein two elements so diverse might be jolued. They ask it because they have the right to so organize their government that the expenses thereof shall be the least burdensome, and that experience demonstrates that the rate of taxation for State purposes is much less in small commonwealths than in larger ones, statistics proving that while the assessment for this purpose in Delaware and Rhode Island is only 10 mills on the dollar, it is in New York 21 mills, and Hilmois 24.
