"I put four chrysanthemum plants by .hemselves and gave them a teaspoonul of ammonia in a gallon of water wice a week. In a fortnight the result was most ptriking, for though I watered the others with liquid cow manure they look lean when compared with the ammonia-watered plants, whose leaves turned to a very dark green, which they carried to the edge of the pots until the flowers were out. As a matter of course the flowers were splendid. I also tried it on strawberries, with the same satisfactory result, the crop being nearly double that of the others."


