

We are hearing a good deal of late about poisons in food containing protein compounds, such as the casein of milk and the myosin of lean meat and fish. The protein compounds are prone to de-cay—that is, to be decomposed by the action of the ferments called bacteris or microbes. In certain forms of decomposition substances of a more or less poisonous nature, called ptomaines, are formed from protein. It appears to be in this way that poisonous compounds are formed in cheese, meats, etc. While the true digestive forments, such as the ptyalin of saliva and pepsin of gastric juice, are very different from the ferments just spoken of, yet microbes exist in the digestive apparatus of even the healthlest people, and within a short time past it has been found that poisonous compounds, formed probably by the action of mi-crobes, often occur within our bodies. The natural inference-it is not posi-tively proved, I think-is that there may

be cases in which the protein of certain kinds of food is thus transformed into injurious substances while passing through the alimentary canal. Perhaps this is the reason why certain persons cannot endure milk without pain or nausea, and it is not impossible that many of the cases in which one kind of food or another causes sickness may, in the light of future research, be attributed to such fermentations within the body.-W. O. Atwater in The Century.


